VILLAGE OF HUDSON FALLS RESOLUTION AUTHORIZING SUBMISSION OF AN EMPIRE STATE DEVELOPMENT RESTORE NEW YORK PROGRAM GRANT APPLICATION

WHEREAS, Empire State Development is accepting grant applications for funding under the Restore New York grant program;

WHEREAS, the Restore New York program is intended to revitalize urban areas and stabilize neighborhoods through funds provided to aid in the implementation of a project of significant benefit to the community;

WHEREAS, such grant money may be used in projects involving demolition, deconstruction, rehabilitation, and/or reconstruction of vacant, abandoned, condemned, and surplus properties;

WHEREAS, the Village of Hudson Falls intends to apply for funds through the Restore New York grant program;

WHEREAS, the proposed project is the renovation of the vacant second and third floors above Everything Under Foot Flooring, at 188 Main Street, which is roughly 10,000 square feet, to provide eight residential units;

WHEREAS, the proposed project implements an overall strategy for revitalization supported in the Village's Comprehensive Plan, as well as the Village's Revitalization Opportunities Program;

WHEREAS, costs over and above any assistance granted by Empire State Development will be financed by the building owner;

WHEREAS, the renovation of the vacant floors at 188 Main Street will help to convert vacant, unutilized space into downtown housing units and to maintain and enhance an important downtown property;

WHEREAS, the proposed project will aid in the creation of new residential space, generating investment in the downtown and a more significant market for existing and prospective businesses and residences;

WHEREAS, the grant application process recommends that the governing body of the applicant authorize submission of the application and related actions; and,

THEREFORE, BE IT RESOLVED, the proposed project is consistent with revitalization or redevelopment plans; the proposed financing is appropriate for the specific project; the project facilitates effective and efficient use of existing and future public resources so as to promote both economic development and preservation of community resources and the project develops and enhances infrastructure and/or other facilities in a manner that will attract, create, and sustain employment opportunities.

A Public Hearing is required to move forward with the Restore New York Program Grant process.

Mayor Comment:

Yesterday the American Legion had their 9/11 Ceremony, and he was able to attend. He would like to express his gratitude to the Legion for hosting this every year.

He would also like to remind everyone present, that the High School is playing soccer at Moran-Derby Park tonight.

Board Comments:

Trustee Horrigan would like to remind the Board of the discussion that we had a few months ago with regards to the Feeder Canal Bike Trail and to be one of municipalities that contribute to the expansion by making a contribution towards a grant match that may be awarded. It has been confirmed that the grant did come through and that they will contacting us to have a discussion on the shared expense and any other details that need to be discussed.

Trustee Gallagher would like to request garbage cans on Main Street in front of the Court House at the bus stop. He explains a small pile of garbage accumulates and he has been picking it up on his morning walks. We will look into repositioning a garbage can there again.

Public Comment:

Shannon Gillis, Pearl Street, expresses her concern that on August 2nd she woke up to DPW cutting down a tree in front of her house. She was under the impression that she is not able to maintain the tree herself. She has called in the past to have limbs trimmed with no response. She points out that she maintains that strip of grass that is Village owned by mowing it and she is to maintain her sidewalk that is Village owned but her responsibility. She proceeds to explain the village trees have destroyed her septic lines that enter in her property.

The morning of the tree removal she asked the men handling the project, to stop what they were doing because the tree was not dead. She was told that they had the authority to cut down the tree and was going to proceed. Ms. Gillis explains her knowledge in biology including varies environmental committees that she is on assisted her in determining that the tree was healthy and should not have been taken down. A brief discussion ensued.

She is requesting for more of a transparency of cutting down the trees and how it is determined when a tree is to be cut down, more specifically a protocol in place.

Bill McCall, Ferry Street, approached the Board and began discussing lawn care and maintenance. He was told over a month ago he was told that yard brush is to be put in bags. Recently there were two DPW workers trimming a tree on Margaret Street, and he took an arm full of brush that he picked up from the Methodist Church and brought it down to them and asked if he could personally throw it in the back of the truck. He was told by the worker's they can not allow him to throw any brush in the back of the truck as they would not allow all other residents to the same. Mr. McCall believes that it does not make sense to allow this as he is trying to keep things cleaned up. Trustee Horrigan would like to find out more information before a conclusion is drawn but he recommends to just bag the brush as required. A timeline is set into place for loose and bagged brush, it is a guideline that is set for all residents. Mr. McCall believes exceptions should be made. A brief discussion ensued.
